I hold JT3 Art, and its officers, employees and agents, harmless, and fully indemnify them from any claims made, damage or loss that may result from my failure to secure such necessary rights and permissions.

I understand that JT3 Art’s uses of my entry shall not be for commercial (i.e., for-profit) gain, but may include promoting and publicizing the non-profit mission of JT3 Art, and its award competitions and recipients. I hereby grant JT3 Art permission to show and exhibit my entry (and any images, excerpts, or promotional materials) at the JT3 Art Celebrates Young Filmmakers event, and I further grant JT3 Art permission to show and exhibit my entry (including images and excerpts from my entry), and promotional materials pertaining to my entry, for promotional or publicity purposes, including through display on the JT3 Art Internet site. Such permission shall extend for a reasonable period of time of not less than 365 days from the date of the JT3 Art Celebrates Young Filmmakers event at which my Artist Award is publicly announced.
8. I agree to abide by the decisions of the JT3 Art award programmers.
